Instructions for uploading documents

Please read the following instructions carefully before proceeding:

- Ensure that all the required documents are prepared in advance, as per the specifications outlined in the table below, and kept in a separate folder for easy access during uploading.
- 2. Upload each document using the exact file name (nomenclature) specified in the table. Document will not be uploaded if any other file name, format or size is used

NOTE 1: Photo upload instructions

- a) Upload a photo named photo in jpg format with a file size between 20KB and 200KB.
- b) Ensure the photo is clear, recent, and shows your full face.

IMPORTANT:

To upload photo, you must ensure that the photo has 3/4th face coverage. This means that the face must cover at least 75% of the area in the photo. Below are some sample photos — some with proper 3/4th face coverage and some without. You must crop or take your photo in the same manner to ensure it meets the required face coverage before uploading. You must also ensure that the photo is of good quality and that they are looking directly at the camera, keeping the alignment of the face proper, straight with both ear lobes visible.

Table 2: DOs and DON'Ts concerning Photograph to be uploaded on portal

Dos	Don'ts
 Use a colour photo in jpg format between 20KB and 200KB, saved with the filename 'photo'. Make sure your face covers 75% i.e. 3/4th area of the photo. Photo background shall be plain white. Frontal view of the full face should be visible, head in the centre and both ears should be visible. Eyes must be open & edges of face must be clearly visible. Expression of the face should be natural (no grinning, frowning, or raised eyebrows). 	 Photograph with dark background or in uniform, or with eyes hidden under coloured or dark glasses will not be accepted. Shadows on the face or on the background should not be there. Eyes must not be covered by hair. Glares on eyeglasses should be avoided. Photograph is NOT to be signed.

2. Signature upload instructions:

- a) Sign on a clean white paper using a black pen.
- **b)** Scan your signature.
- c) Make sure the image is clear, well-lit, and without shadows.
- **d)** Save the signature file in jpg format with file name signature.
- e) Ensure the file size is within the specified limit
 - i. Between 20KB to 100 KB and
 - ii. Between 350 pixels to 500 pixels
